## Boarding and Day Camp Contract

Camp Rawhide as referred to herein and the undersigned owner or person having custody of the following animal agrees as follows:

- 1) The undersigned requests the kennel board the pet(s) named \_\_\_\_\_ and agrees to pay for each day of boarding and for all agreed upon services in advance.
- 2) Camp Rawhide does not guarantee immunity against communicable disease beyond its control. Should such sickness develop Camp Rawhide reserves the right to incur the cost of veterinarian service, the cost of which the undersigned agrees to reimburse. Camp Rawhide is not to be held liable if it fails to secure veterinarian care.
- 3) Upon failure of the undersigned to pay board and day camp bill or fail to pick up pets as specified in this contract, Camp Rawhide is hereby authorized to sell or otherwise dispose of said animals in its absolute discretion per civil code #1834.5 (the abandoned animal act)
- 4) All animals are boarded or trained or otherwise cared for by workers of Camp Rawhide without liability on their part for: loss or damage from disease, running away, theft, fire or injury to persons or pets, property by said pets or other unavoidable causes, due diligence and care having been exercised.
- 5) The undersigned releases Camp Rawhide, its owner and employees, from all risks and damages with may occur during pets stay.
- 6) The provisions in this agreement apply to any future time the undersigned owner boards the same or other pets at Camp Rawhide. This agreement will be signed only once
- 7) Animals showing infestation of fleas and ticks will be shampooed and treated at owners expense of a maximum fee of \$40.00 we make every effort to maintain a flea-free environment however we cannot be responsible for occasional occurrences of fleas.
- 8) Dog's paws may become irritated by the various floor surfaces when they play in the play yards. All efforts are made to prevent dog's feet from becoming irritated, however Camp Rawhide and its staff will in no way be held liable for any injuries to the dog's paws or to any other body part.
- 9) I hereby agree that if my pet should require emergency medical attention while in the care of Camp Rawhide my pet will be treated at Napa Small Animal Hospital; I will be responsible for reimbursing Camp Rawhide for any and all veterinary expenses incurred. I agree to reimburse Camp Rawhide when I pick up my pet.

10) Canine Cough can be contracted any time your dog comes into contact with another dog. All dogs boarded at Camp Rawhide have a Bordetella Vaccine every 6 months but the Bordetella vaccine is like the human flu shot and does not immunize all dogs against all strains of the canine cough. Camp Rawhide and its staff will in no way be held liable for any type of canine cough my dog may contract while at Camp Rawhide.

11) Some dogs do not do well in a boarding kennel and we will do as much as possible to make the dogs feel comfortable, including putting them in our offices or other rooms in the kennel. Symptoms of stress include excessive barking, panting, and diarrhea. To alleviate the stress Camp Rawhide has my permission to give a mild sedative if the veterinarian agrees.

12) I agree to pay the fee of \$13 if I pick up after 1 o'clock pm.

Agreement to hold harmless, waiver and assumption of risk

I want my dog to receive exercise and play time with other dogs at Camp Rawhide. My dog is well socialized with other dogs. My dog will not attack or bite another dog.

I understand that this is not without risk to my dog, because some dogs may bite or injure each other while playing.

I understand that it might take a while for dogs to become accustomed to group play. Initially their feet may get sore until they become accustomed to playing on gravel, grass or other surfaces designated for play. Generally this soreness does not present a problem and goes away after the dog has spent a few days playing at Camp Rawhide.

I understand that my dog's feet might get sore if they run or play hard in designated play areas. I understand that sometimes gravel fox tails can get caught between dogs toes and that this can cause a dog to limp.

I hereby waive and release Camp Rawhide and its employees from any and all liability of any nature of injury or damage which my dog may suffer, including specifically, but not without limitation to an injury or damage resulting from the action of another dog, and I expressly assume the risk of such damage or injury.

In consideration of and as inducement to the acceptance of my application for my dogs participation in group exercise and play with other dogs at Camp Rawhide, I hereby agree to indemnify and hold harmless Camp Rawhide and its employees from any and all claims

I hereby waive and release Camp Rawhide from any liability for injury or damage my dog may suffer while under the care of Camp Rawhide. This includes escaping from fences. I expressly assume the risk of damage or injury that may occur due to any of the aforementioned in this statement.
